
President Grayce Baldwin will bring us up to date on the events that affect all of us in the Hollywood Heights Assn

"A man for all reasons and all seasons." That's our vice president, Elliot Johnson. Though Elliot started out in Brooklyn, he's lived all over the world: Rome, Tangiers, Kenya. But when he came to So. Calif., Elliot knew he was home. He plans to stay.

Beneath an urbane, sophisticated exterior is a hard-working, hard-driving, down-to-earth activist. Elliot is on the Citizen's Advisory Committee of the RTD. And tells us that we must monitor their meetings regularly unless we want to have a subway running under our hills.

# TREASURER'S REPORT

While not extra impressive, the Association's finances are in somewhat better condition than Braniff's coffers with \$1,193.48 in its Bank of Hollywood account as of March 21. This amount has been generated almost entirely from dues paid by the approximately 200 members with some funds derived from sales of Association decals.

Treasurer Don Wakefield's current concern is not the size of the bank account, but the lack of sign-ups for the security service to be provided by Foothill Patrol. There are currently twelve commitments to pay the \$20 monthly fee, although service cannot start until at least 45 homes have been enlisted.

Association expenses have been primarily for publication of the newsletter with other expenses being for decals and stationary. Decals can be obtained by sending \$1.00 to Don Wakefield, 2152 Rockledge Rd., Hollywood 90068. Don says that he appreciates the inclusion of a self-addressed, stamped envelope, something that many purchasers have done without having been previously asked. These decals will greatly simplify entry through the "Berlin Wall" and onto Camrose Ave. once the Hollywood Bowl season has started.

Membership sign-ups have been favorable, and if you're reading this, you probably are a member. If you're not and wish to do so, please send \$10 per member of your household to Don Wakefield at the above address, or leave it at the Association's box at the corner of Camrose and La Presa.

(Few members of the HHA knew that in our midst lived one of the most glamorous stars of early Hollywood, Alice White. But among those who knew and cherished her was Association member, Nita'Thomas, who wrote this after the actress' recent death.)

In 1924, Camrose Dr. not only had a beautiful view, but was enfolded by lovely trees. A choice of vacant lots was available, and on one of them at the Hightower corner, Alva Alexander and her husband, who had come west from New Jersey, built a gracious Spanish house. It had a special bedroom, bath, private entrance and porch for their granddaughter -- who was to become known as Alice White.

At that time, she was known as Alva, a petite beauty who worked as a script girl for Charlie Chaplin. One day he said to her, "Bunny, you should be in front of the camera, instead of behind it." A screen test was arranged, Alva became Alice, and the auburn hair was changed to blonde (as Clara Bow, the "It" girl, was already the brunette star under contract at the same studio.)

In 1926, Alice White made her first film, "Sea Tiger", starring Mary Astor. The production was not a success, but Alice got rave reviews as the newcomer who ran away with the show.

During a career in which she made 35 movies, Alice was in such films as "Gentlemen Prefer Blondes" for Paramount in 1928 and "Flamingo Road" in 1949.

In 1938, Alice appeared on stage at the Belasco in "Dinner At Eight". Her leading men included James Cagney, Chester Morris, Robert Preston, Neil Hamilton, Edward G. Robinson, and Andy Devine. Alice made films in England, where she was extremely popular. For Tiffany Productions, she made a film entitled, "Lingerie", and for Gainsborough she made "Where There Is A Will", with William Bodin.

Vaudeville was another endeavor for Alice. She toured the circuit with her own company, and was billed as "The Blonde Blaze".



By the 1950's, Alice was tired, and agreed only to guest appearances on TV shows with such stars as Ann Sothern. In the 1960's, she retired, living here in the same house where she had been raised by her grandparents. She recalled that her grandmother, in the old days, made a ritual of lunching every Thursday in the bay window of the Hollywood Blvd. restaurant, Musso and Frank, observing the glamorous stars going by and basking proudly in the knowledge that her own granddaughter was one of them.

Alice protected her privacy, and would have succeeded in becoming "that colorful Camrose recluse" had it not been for her humanitarian concern for her neighbors and her compassion for animals. It kept her door open.

She left so suddenly, we did not have "Alice, we were time to tell her: warmed by your contribution to our hill, and by the aura of the original Hollywood glamour. We will miss you and we will cherish the memory of the green Thunderbird dashing down the street with the pert driver behind the wheel, wearing sunglasses under that cartwheel hat. Nestle in peace into your honored star next to that of Jack Benny on Vine St. When we pass that spot, we will smilingly say, 'She's at it again', for surely Alice will be tossing oneliners to Jack."


#### **NEW COMMITTEE HEAD**

Dear Neighbors:

We need your help -- very briefly, let me explain: In 1980, a coalition of Hollywood Heights and Whitley Heights residents were able to put certain conditions on a developer's proposed tract map for 57 condominiums at 2026 N. Highland Avenue. One of those conditions was that NO ENTRANCE OR EXIT COULD BE MADE INTO LAS PALMAS AVENUE, the small sub-standard hill street that abutts the rear of 2026 N. Highland, and can barely handle traffic for its fifteen homes.

The condos were never built, but the developer is back on the same lot, and has begun construction of 81 low-rent apartments (bachelor "juniors" and one-bedroom units). He now calls his company THE HIGHLAND DEVELOPMENT COMPANY. His main entrance is planned for 2039 North Las Palmas Avenue. 81 units will be using a small residential R-1 street that has more safety hazards and parking problems than any other of our streets. There was no public hearing. The bulldozers simply showed up and began work. This is apparently a legal procedure!

We ask that the original condition of the condo tract map, that no entrance or exit be made from Las Palmas be re-instated to this project, and that a traffic survey and an environmental review be done for the Highland corridor from Franklin north to the Freeway, and all side streets in the corridor.

We feel this is vital to our future safety and well-being. The important facts and addresses are below. Please write a brief letter supporting our position.

What happens to WHITLEY HEIGHTS today, will happen to HOLLYWOOD HEIGHTS tomorrow ---- and vice versa --- we must stick together!

FACTS THAT MUST BE INCLUDED IN THE LETTER: Construction permit #59314 issued March 2, 1983 for building on lots addressed at: 2039 N. Las Palmas Avenue: 61 Junior apartments plus 20 one-bedroom apartments. WE DEMAND A TRAFFIC SURVEY OF THE HIGHLAND CORRIDOR and an ENVIRONMENTAL REVIEW of the area......EXTREMELY IMPORTANT: Previous tract map for condos #39371 had a conditon imposed by City Planning that NO ENTRANCE or EXIT was to be allowed from this property onto Las Palmas Avenue. We demand this condition be reinstated on this permit.
