

CITY COUNCIL DECLARES
HIGHLND-CAMROSE BUNGALOWS
HISTORIC LANDMARK

#### GUEST OPINION -

I would like to thank the editors of "THE VIEW" for allowing me this space in what I believe is one of the finest neighborhood newspapers that I have ever seen or read.

My views of the proposed Hollywood Community Redevelopment Plan (C.R.A.) are candid and are my own opinion.

I believe the C.R.A. is the only available agency at this time with enough power and planning behind it to reverse the blight and deterioration of Hollywood. Both the power and planning are of great concern to me. power can be misused, and the planning could lead to a crippled, desolate city. I believe, however, that these two elements can be controlled by strong citizen input. applauded or disapproved of various aspects of the plan as an outsider to the process. I was not eligible to be a member of the Project because I lived Committee (P.A.C.) outside the project's boundary. I was very disturbed as it became evident to me that the P.A.C. was voting in favor of maximum densities for most areas, even though the streets and parking weren't available to handle these densities.

Councilwoman Stevenson, in an attempt to balance this citizen's advisory body, appointed me to the P.A.C. in March of 1985.

Much of the plan is ready for approval, and I have had little chance for input on its Still, I feel it is worthwhile to serve on the P.A.C. and perhaps have some influence on future decisions. I still believe C.R.A. can rebuild Hollywood in a meaninful way. I believe that the P.A.C. is still strongly pro-density, and not likely to The P.A.C. and its committees are change. often rushed to a decision by staff without time to study issues. Community input is controlled by the procedure of having citizen participation at the end of a P.A.C. meeting, after issues are discussed and votes taken.

My thought is this: Let us participate in good faith and confidence. The Redevelopment Plan cannot be adopted until the Hollywood Community Plan is amended. This will involve public hearings before the Planning Commission. The areas outside the project must be considered at these boundary hearings. Let us all be there.

#### GUEST OPINION

"Sub-area 1", the apartment area at the base of our hills and Whitley Heights, has probably generated more comment and conflictin recent public hearings than any other of the Community Redevelopment Agency's sub-area in the 1100-acre Hollywood project.

Four principal concerns were voiced by citizens: views to and from our hillsides traffic overloading our streets; parking spillover into our residential neighborhoods and design quality of future construction However, many felt that a strong incentive, in the form of high density for new construction was needed to draw developers into the area to spur on its upgrading.

The error is classic: "good" and "evil' are equated with antidevelopment and development. To many minds, evil won, as a density of 130 units per acre (reduced from 250) will be allowed in the future.

What is sad that many elected is representatives of Hollywood--my fellow PA( members---ardently believe that the only hope for Hollywood is in quantity of allowable new development. They miss the lessons of building rehabilitation and of high quality, low density neighborhoods (say Beverly Hills). Hillside people equate the limiting of new construction with solving our problems; unfortunately, such limitation does nothing to solve today's traffic and parking problems.

#### FOLLOW UP

In the last VIEW we printed copies of letters sent by the HHA and Whitley Heights Civic Assn. to the presidents of Hughes Market and the L.A. Philharmonic Assn., asking for meetings about various problems.

The Philharmonic Association representative has set a meeting this month (May), and details will be given to you in the next VIEW. So far, no response from Free McLaren, president of Hughes.

#### WHAT'S WRONG WITH THE POST OFFICE?

When the HHA purchased a bulk mail permit for \$80, so that we could mail the VIEW, we were told that delivery would be made between 5 and 10 working days. Besides the \$80 annual fee, of course, the HHA must pay for the cost of each mailing.

Copies of the last VIEW, which we hoped to get into your hands well before the March 26 public forum of all candidates for the 13th District Council seat, were taken to the downtown Terminal Annex on March 14. All of the VIEWS with the 90068 zip codes were bundled together, and kept separate from other zip code addresses.

We are sorry to report that most of the HHA members received their VIEWS long after the March 26 meeting, some of us in mid-April, a MONTH after the post office received them! There has been no reasonable explanation from the postal authorities.

Also: The postmaster has not responded to our petitions for the return of the sub-station on Highland Avenue, nor to our request for a Hollywood postmark, which we once possessed. A copy of the VIEW making these requests was mailed to Postmaster Charles King. Maybe his copy was lost in the mail, or is taking even longer than a month to arrive.

for 7 p.m. (no host cocktails) with the forum to start at 7:30 p.m. The place is Yamashiro Inn.

Here's how the program will work:

The candidates will first answer three major questions formulated by the HHA Board of Directors to represent the most urgent interest of membership. Then, written questions submitted from the audience will be asked by the moderator John Schwada of the Herald Examiner. The presentation is expected to last one hour with a timer keeping things on schedule.

The June 4 election will be the second runoff in which Woo and Stevenson have each other. Woo, who lost to Stevenson in 1981, took nearly 35% of the vote in this year's primary, forcing the Stevenson won 42% of the primary not the majority needed to win vote. reelection. Woo was one of five candidates challenged her in the who primary.

Among the issues which have confronted the candidates during their campaign are questions about crime, revitalization of Hollywood and the threat of commercial development in residential neighborhoods. Another issue which is cruical to HHA residents is traffic congestion on Highland Avenue.

If you want to know how the candidates will address these problems, bring your questions and come out for the candidates' forum. A strong showing will serve to impress upon both candidates the importance of Hollywood Heights in their future plans.
